**WHEREAS** CUPE 3903 is a union representing over 3,700 members representing contract faculty, teaching assistants, graduate assistants, and research

**WHEREAS** the current collective agreement between CUPE 3903 and the their employer, York University, expired as of August 31st, 2023, with members having to work without contract since then; and

WHEREAS the current cost of living is at an all time high, with many community members facing food insecurity and housing precarity; and

**WHEREAS** Bill 124 was passed in 2019 by the Ford government, capping the year-to-year wage increase to a maximum of 1% for public sector workers and since repealed by the Ontario Government, deeming it to be unlawful; and

**WHEREAS** CUPE 3903 is bargaining to provide its members with livable wages and retroactive payments after the repealment of Bill 124, among other items; and

**WHEREAS** the union has overwhelmingly voted to reject the employer's final offer, and subsequently voted to strike; and
